PRC Conducts Special Professional Licensure **Examination for CPAs in** Abu Dhabi

The Professional Regulation Commission (PRC) successfully conducts its annual Special Professional Licensure Examination (SPLE) for Certified Public Accountants (CPA) for Overseas Filipinos in the United Arab Emirates last August 12, 13 and 14, 2019.

Held at Philippine Global School, Abu Dhabi, UAE, this year's examination includes 24 professions such as Architects, Certified Public Accountants, Chemical Engineers, Civil Engineers, Dentists, Electronics Engineers, Electronics, Technicians, Environmental Planners, Geodetic Engineers, Mechanical Engineers, Certified Plant, Mechanics, Master Plumbers, Midwives, Nurses, Physical Therapists, Professional Teachers, Psychologists, Psychometrician, Registered Electrical Engineers, Registered Master Electrician, Radiologic Technologists, X-Ray Technologists, Respiratory Therapists and Veterinarians. In the UAE, 113 examinees has registered for the CPA board examination.

The SPLE was facilitated by the PRC representatives all the way from the Philippines and Philippine Professional Organization - UAE (PPO), with the support of volunteers from various National Professional Organization of the Filipino community in UAE, in coordination with Philippine Overseas Labour Offices in Abu Dhabi and Dubai.

PICPA Dubai Chapter as part of its annual commitment to support the CPA aspirants were represented by volunteer marshals namely: Catherine Hermosa, Micah Feliciano, Noemi Garcia, Rovilaine Marie Pinat, Kris Jason Abendaño, Fernando Gundayao Jr, Merry Cristy Joy Palo, and Edmund Santos.



"For me, no time is better spent than that spent in the service of your fellow man. Being here is a manifestation of the PICPA Dubai vision as an organization of Certified Public Accountants committed toward the professional excellence of its members, nation building and with a global perspective", Ms. Rovilaine Pinat, one of the PICPA Dubai Officers said in an interview.

The Special Professional Licensure Examinations (SPLE), which started in 1997, give Filipinos who are working and living in other countries the opportunity to take licensure exams without requiring to go back to the Philippines. This program has had spared the examinees from expensive travel expenses and rigorous process of special permits from embassies and employers alike since then.

Although it is not confirmed when will the PRC release the official list of passers, the results are usually posted in the PRC website and announced in various local and international gazettes after two months.





However, not all of us lived a life with a silver spoon handed over. The idea of becoming that "person" may be a luxury for some, if not most of us, to afford due to certain harsh realities of life which are truly inevitable. I grew up in a small rural community together with my family and extended relatives fully aware that we could only afford the basic necessities of life and working hard was an essential attribute of survival. Remembering that little Alexis, I could say that I only had a simple dream – to become the "person" that my Parents will be proud of. That idea was so grand that even my juvenile mind could not even comprehend. Way back then, I had so much hopes and aspirations until LIFE happened.

There, I experienced a lot of "firsts" in my life – from my first salary to my first time being shouted at by a co-worker. I never thought that life as a working professional would become a completely different story from what I used to have. The pressure had already moved to the next level –of giving back to my family and at the same time meeting the expectations of my employer and clients. I have stumbled a lot of times and missed my first promotion cycle which truly broke me. I thought everything was already over and maybe I shouldn't have expected much to avoid being disappointed in the end. My first career became the center of my life that I already forgot and lost track of the things that truly mattered to me – my Family – which I consider the biggest failure I've ever had.

Throughout our lives, we will experience a cycle of setbacks, moments where we fell short, and fight with so much battles of disappointments and failures, only bringing with us the tiniest hope that is left from that cycle. I've been to so many failures than I would like to admit. But one thing I came to realize from everything I've experienced and that this is clause I came through when I was reading an article — without failure, we'd be less capable of compassion, empathy, kindness, and great achievement; we would be less likely to reach for the moon and the stars. This Month in Finance History

06 August

1906: On August 6, 1906, the system of weights and measures were reformed and legalized in terms of the metric system, when the Philippine Commission Act No. 1519 was enacted.

Today in Philippine History, August 6, 1906, the system of weights and measures were reformed

Act No. 1519 took effect Janaury 1, 1907.

A careful study of the matter by government experts in the Bureau of Science, found that the standard weight and capacity had become deplorably falsified and irregular. It was commonly said that the only reliable unit of measure was a "Standard Oil Can". The debasement and frauds practised fell heaviest upon the poorest purchasers and consumers. Thus, it was decided to standardize the native measures and adopt the international metric system.

The "kaban" was made exactly equal 75 liters. A "ganta" was made 3 liters. "Chupa" was made 375 thousandths of a liter
