

### PICPA Dubai shares HOPE

PICPA HOPE project has been running successfully for three consecutive years as part of PICPA's community and social initiative. With the main goal to help others to progress and excel, the project has given Filipino women in unfavourable situation second chances and meaningful optimism in life. This year, 150 distressed overseas Filipinos attended the event at Philippine Overseas Labor Office (POLO) last February 21, 2020 in Muhaisnah 4, Dubai, United Arab Emirates.

PICPA Dubai Chairman Lyndon Magsino kicked off the program with a financial talk which focused on imparting HOPE by changing old habits, finding simple opportunities in life, having a positive outlook and getting educated or continue learning new things. Magsino reminded our kababayans that their current situation is only temporary and they are momentarily 'under process' now as things will get better.

In her inspirational message, PICPA Dubai Chapter President Christine M. Filomeno asked our attendees to share their positive and motivating experiences. A lady from Quezon province was very appreciative that she was brought unscathed to POLO-Dubai during a ninety-minute journey from Ras Al-Khaimah despite having no money on hand in paying the taxi driver she just met that eventful day. She added "The driver was kind, he helped me and the POLO OWWA is a big help! (Mabait po ung driver, tinulongan nya ako at ang laking bagay po ng Polo Owwa)".

Another overseas Filipino shared that she preferred being here at Polo Owwa as she felt safe in the company of fellow Filipinos unlike in her employer's house. She said "I feel more okay here because I might lose my sanity there (employer's house) thinking about things (mas okay na ako dito kasi doon baka mabaliw pa ako doon kakaisip')".

One woman from Cotabato city is thankful that she will finally return home to her loved ones in the Philippines after working for nine months without pay while others are grateful that their cases will be eventually heard at Dubai courts with the help of POLO-Owwa (Overseas Workers Welfare Administration) officers.

Labor Attaché Felicitas Q. Bay recognized the efforts of PICPA Dubai in sharing their blessings to our less fortunate kababayans through this initiative which has impacted around 700 Filipinos since inception. Games, dance & song presentation and raffle draws brought laughter and smile among the women. Personal gifts were given to each attendee together with some groceries and prepaid cards to communicate with their families back home.

PICPA's community and social responsibility (CSR) is headed by Ms. Ernielyn Amorganda and Ms. Jorylin Virayo. In 2017, the HOPE project was able to repatriate 3 overseas Filipinos back home. Currently, PICPA has three scholars in the Philippines under its CSR initiative.

# Philippine Professional Organization United Arab Emirates (PPO-UAE) Oathtaking Ceremony

The landscape of Filipino expatriates in the UAE has drastically changed, as more professional workers are coming in as compared to previous generations leaning towards low-skilled workforce. It cannot be denied that Filipino professionals have been paving the way towards excellence within the country.

PPO-UAE, an umbrella organization of 20 professional organizations with various disciplines such as engineers, architects, teachers, medical professionals, veterinarians, and accountants – just recently held their induction of officers and representatives last February 21, 2020 at Marriott Downtown Hotel, Abu Dhabi.

PPO-UAE is famously known as the facilitator of the Special Professional Licensure Examination (SPLE) for qualified Overseas Filipino Workers (OFW) in cooperation with the Philippine Embassy/Consulate, Philippine Overseas Labor Office (POLO), and the Professional Regulation Commission (PRC).

The current executive committee of this fiscal year (FY) 2020 is led by Chairman Mr. Ramel C. Cenil from Filipino Radiographers (FILRAD) - Abu Dhabi, while PICPA Dubai's Ms. Catherine R. Hermosa will still hold the position as the organization's Auditor, for the successive year.

During the event, the officers were blessed to hear an inspirational speech from our own Consul Maria Cynthia Pelayo from the Philippine Embassy in UAE. Speaking from her experiences as being assigned to different countries, she has highlighted the standards and ethics that Filipino professionals should strive to uphold. Filipinos - as flexible as we are, should absorb the positive attributes from other cultures to complement with our brand of hospitality and diligence.

It should be noted that 1,241 OFWs from all the different disciplines took the SPLE last year. As to the CPA licensure exam, 2 out of 164 (1.22%) takers passed the exams. As an update, SPLE for this year 2020 is tentatively scheduled on either the last week of July or first week of August. We shall be awaiting further updates from PRC for further information, especially as to the deadline on submission of documents.

To end, we as Filipino professionals should not forget the importance of our roles - when it comes to the UAE and Philippine economy. We should aim to be globally competent when it comes to essential and technical skills – making a mark in our respective industries.

## Passive Income from Stock Ownership

A full-packed learning experience entitled 3 in 1 Seminar: Emerging Leaders in the Digital Age, VAT Compliance & Beyond and Passive Income from Stocks Ownership has been conducted last November 8, 2019 at Ibis One Central Hotel, Dubai World Trade Center. PICPA Dubai invited international resource speakers Mr. Ron Thomas to tackle digital age leadership, Mr. Hemant Mundhra on pre- (past) & post-implementation (present) and future of VAT in the UAE, and Mr. Lyndon Magsino about stock market investments – concepts and strategies. The room was filled with the presence of audience full of enthusiasm about their professional and financial well-being.

PICPA Dubai Chapter Chairman Lyndon Magsino formally opened the event by instilling to the participants to excel in everything that they do. As he quoted, "Average is just not good enough. Average is a failing formula." Moreover, he left a brave challenge to everyone to find their purpose.

As one of the Top 5 HR Thinkers in the MENA region - Mr. Thomas' keynote message to all PICPAns is to continuously improve, develop and adopt themselves in a very dynamic environment. He cited that according to Organization of Economic Cooperation and Development, 46% of all jobs have at least a 50% chance of being lost or greatly changed. Leaders should have a right mindset and be equipped with skills to handle all that may lie ahead. He emphasized that leadership is driven with continuous improvement, connection with people, and openness to criticism.

During lunch, PICPA Dubai President Christine Filomeno acknowledged Francis Miguel Sales, one of the 2 passers of the CPA Licensure Examination held here in the Middle East. PICPAns showed a warm welcome to the newly-passed CPA in PICPA Dubai community.

After a heavy lunch was followed by a much heavier topic – VAT Compliance and Beyond. Tax expert and experienced in the VAT implementation, Mr. Mundhra, sliced the topics on several subjects for everyone to digest lightly. He started with an appetizer of establishing the basic VAT concepts. He then served the main dish of understanding the challenges and issues encountered in the VAT compliance and explaining the role of accountants in the record keeping and VAT reconciliation. He added a dessert with cherry on top by discussing the essence of Economic Substance Regulations (ESR) which is a recent requirement to ensure that the businesses in the UAE are conducting within their relevant activity. After a very comprehensive discussion, the audience tipped Mr. Mundhra with an interactive Q&A portion.

PISO Master, Mr. Magsino gave an insight on how to be an "emvestor" – being an employee and investor at the same time. PICPAns were reminded to take out the accountant mindset, and rather wear the hat of an investor throughout the discussion. Mr. Magsino taught the attendees with one strategy – Cost Averaging. This is an investment strategy in which an investor divides up the total amount to be invested across periodic purchases of a target asset in an effort to reduce the impact of volatility on the overall purchase. The purchases occur regardless of the asset's price and at regular intervals; in effect, this strategy removes much of the detailed work of attempting to time the market in order to make purchases of equities at the best prices.

The whole day event enhanced and sharpened everyone's soft skills as a leader, technical skills as an accountant and financial skills as an investor.



As the Philippine Institute of Certified Public Accountants in Dubai (PICPA-Dubai) cultivate the culture of healthy mind and body, the inaugural sports festival dubbed as PICPAlaro was an overwhelming success with around hundred participants under three different sports events of basketball, volleyball and badminton.
